1.0 Samoa Water Authority Vehicle Open Auction.

1.1.0 Specific Instructions & Conditions

The Samoa Water Authority (SWA) is disposing **Eight (8)** surplus vehicles. Interested companies, businesses, organizations, groups, or individuals are invited to submit bids for one or more vehicles.

2.0 Bidder Registration Eligibility.	 Bidders must register before the auction date as stated by the auctioneer (SWA), present valid government issued ID. Minimum age requirement (typically 18+) applies.
3.0 Bidding Process Auctioneer Authority	 Auction follows a defined format (open auction/English/Samoan); the auctioneer's "Bell Ring" indicates a binding sale.

		 The auctioneer can accept, reject or withdraw bids or lots and resolve at their discretion- their decision is final.

5.0	Bid Deposit	 Bidders must arrange inspections with: Faamatauga Tavae. Email: faamatauga.tavae@swa.gov.ws. Ph Contact: 20409. Bidders are responsible for 'Inspecting Vehicles" before bidding. Submitting a bid without a 'Prior Inspection' is at risk of the bidder. Failure to inspect does not justify bid withdrawal. A "Refundable" bid Deposit of "\$50 per Vehicle, Samoan Tala" (cash) must be 			
3.0	δια <i>σ</i> ερονίτ	 A Retundable bid Deposit of \$50 per Vehicle, Samoan Tala (cash) must be paid at "SWA Vaitele Booth, Vaitele Market". The "COPY" of the receipt must be attached to the "registration "Form A & Form B". The 'Bid Deposit' is secured upon official "SWA receipt issuance". Refunds are issued upon bidder identification or company letterhead confirmation, with a signed acknowledgment. The Bid Deposit will be "Forfeit" if the "Successful bidder" fails to deposit the Sale Price within the prescribed time limit. The Bid Deposit will also be "Forfeited" if the "Successful bidder" withdraws his/her bid after being notified of acceptance/award. 			
6.0	Reserve Prices.	 All the auction fleets have "reserve prices"; Unless they meet, the lot may not be sold. 			
7.0	Payment Terms	 The successful bidder must pay the "Sale Price" by "cash or bank cheque" within three (3) hours of acceptance notification doing the "auction calling". The sale is finalized upon payment and signing the "Sale & Purchase Agreement" Noncompliance may lead to bid rejection unless otherwise approved. 			
8.0	Vehicle Removal & Storage.	 Vehicles must be removed within a defined "48-hour" period of full payment. Storage fees accrue after the removal deadline; vehicles unclaimed after an extended period of 14 days may be resold or deemed abandoned. 			
9.0	Title Transfer & Risk	 The title passes once full payment clears; vehicles may only be removed after this. Risk transfer to the buyer at the point of "Bell Ring" or handover – buyers are then liable for the condition, even if not yet removed. 			

10.0	Mileage, Condition, Documentation.	Mileage stated is guidance only unless explicitly warranted via history records.
11.0	Liability & Dispute Resolution	 The auctioneer and seller disclaim all warranties, including title, quality or fitness for purposes. Buyers agree to indemnify the auctioneer/seller against any claims.
12.0	Seller Obligations	 The seller must ensure the vehicle is accurately described, free of finance unless stated.
